

## Premium member news

### Global Development Institute (GDI)

[GDI academics have been awarded over £350,000 to lead three strategic networks](#), bringing together various partners to carry out innovative research:

- **Professor Richard Heeks** and the 'Development Implications of Digital Economies (DIODE)' network will receive £129,000 as part of the Economic and Social Research Council's Global Challenges Research Fund (GCRF) to look at the growth of digital technologies in the developing world and their impact upon work and businesses.

- **Dr Admos Chimhowu** will lead the Strategic Network on 'New National Planning for Sustainable Development in the Global South' which has been awarded £130,000, also by the GCRF, to address 'new national planning' and its role in helping governments achieve the 17 UN Sustainable Development Goals agreed in September 2015.



- **Professor Diana Mitlin** was awarded an International Network Grant by the Leverhulme to lead on a network looking at 'Achieving Inclusive Cities through Scaling up Participatory Planning in Africa'. The network was awarded £120,000 to bring together civil society action-research agencies and academic departments in three sub-Saharan African countries and at Manchester, including the Global Urban Research Centre.

### 100 Leading Global Thinkers 2016 Award

Professor Alexander Betts, Director of the Refugee Studies Centre (RSC) at ODID, and Professor Sir Paul Collier of the Blavatnik School of Government were named among 100 Leading Global Thinkers of 2016 by Foreign Policy. The award was in recognition of their proposal – now being realised – for the establishment of special economic zones (SEZs) in countries such as Jordan where displaced Syrians would be able to work. ## King's College London

[Andy Sumner](#), a Reader in the Department of International Development at King's College London, was awarded an **ESRC Global Challenges Research Fund Strategic Network Grant** focusing on 'Global Poverty and Inequality Dynamics' in emerging economies. The network will draw together an international team of academics, civil society organisations and policymakers to study economic development and inequality dynamics in rapidly growing developing countries such as Indonesia. This initial stage will draw these key stakeholders together, from both emerging economic and OECD countries, in order to establish a new research agenda in order to generate a project for future enquiry.



With the support of the Department of International Development (DID) at King's College London, Dima Alazzi and Hannah Bailey, both DID alumni, are organising the [Development Tuesdays](#) speaker series. **Giles Bolton** led a discussion on the private sector contribution in job creation at the Development Tuesday event, held 10th January at King's College London. Giles is the "Responsible Sourcing director" at Tesco and the Board Chair of 'Publish What You Fund', an NGO looking at transparency and accountability in the use of aid funds.

Securing access to decent jobs for women and the poorest is one of the biggest challenges faced by developing countries. Governments need to design broad-based strategies that support industrialisation and industrial upgrading to open up avenues for wages, and skills development. At the [Linking in: jobs, wages & skills for inclusive industrial growth](#) workshop on 18 January, hosted by ActionAid and Department of International Development, King's College London, discussion centred on what approaches have been taken so far, what has worked, what has not (and why) and how to paint a brighter future.
